20TH ANNUAL MAKO/THRESHER MANIA TOURNAMENT

With over \$135,000 in cash, plus custom trophies, and other prizes up for grabs last year, this is one Tournament that the avid Shark Fisherman doesn't want to miss. Forty private and charter boats along with over 240 anglers competed for top honors in this 2-day early August event.

Day One's big winner, and the eventual tournament overall winner, was caught aboard Capt. Bob Rochetta's "Rainbow." A longtime Star Island Tournament participant, Capt. Bob put angler Ron Hughes on a 174-lb. Mako and he never let go! When the final fish were weighed on Day Two, the crew of the "Rainbow" earned winnings of over \$87,000 for the tournament. The next biggest winner in the Mako Division was the third heaviest Mako of the tournament. Landed on Day Two aboard the "NorthStar" by angler Chris Gramlich, this 116-lb. Mako earned the crew over \$12,000.00 in winnings. The next biggest winner in the Mako division didn't even crack the top three in weight. Angler Jim Dalenta's 112-lb. Mako earned the crew of the "White Hawk" over \$8,500 in prize money.

Day Two was the day for the crew of the "Alyssa Ann" to shine. Anglers John DeLuca's 247-lb. Thresher swept the Thresher category. The lone qualifying Thresher of the Tournament earned the crew just shy of \$10,000 in winnings.

So circle your calendars for August 2-4 as this two day competition kicks off with the Captain's meeting on Thursday night August 2nd at 7:30 pm. Tournament fishing is held on Friday and Saturday August 3rd and 4th from 6 am-6 pm. With prizes sure to be in excess of \$100,000, this is the late season tournament you won't want to miss!!!

For those sportfishermen who want to get in on the action but don't own a boat, the Star Island Yacht Club Charter Fleet are available for either ONE or BOTH days of the tournament. So round up your crew and get in on the fun August 2nd-4th, 2012 at Star Island Yacht Club in Montauk.

ENTRY FEE \$600 PER BOAT

RULES & REGULATIONS

- All boats must sail from and return through Lake Montauk each fishing day.
- Each boat will be issued a tournament number, which must be prominently displayed in the port side cabin window.
- No boat may leave the inlet before 6:00 A.M. and boats must return by 6:00 P.M. on Friday and 6:00 P.M. on Saturday.
- Minimum weights on all makos is 100 lbs. Threshers, 150 lbs. Fish weighed that do not meet the minimum weight may count against a team's qualifying fish weight.
- All I.G.F.A. tackle rules apply. Use of mammal blood or flesh is strictly prohibited. No guns, bang sticks or harpoons.
- Fishing will be held each scheduled day, Captain's choice, no weather committee. Only one day need be fished for the tournament to be considered official.
- All fish must be available for weigh-ins at S.I.Y.C. by 6:00 P.M. on Friday and 6:00 P.M. on Saturday. Weights will be rounded to the nearest lb., with exact 1/2 lbs. being rounded up.
- In the event of less than 25 boat entries, the prize money will be adjusted accordingly in proportion to the number of entries.
- Should there be a tie in any cash prize category, the prize money will be divided equally among the winners.
- In the event of a boat disability, contestants are allowed to transfer to another boat not entered in the Tournament, and fish in the name of the original. Fish may not be transferred to another boat.
- Any protests must be presented, at the time of the alleged infraction, to the Tournament Directors. They, and the Weighmaster, shall serve as judges in such cases and their decision is final.
- In the event of a two-day blow, as per boat safety and judge's decision, prize monies and trophies will be awarded by a drawing.
